A Message from the Chair and CEO

This report covers the extended period from July 2015 to December 2016. A decision was made to change the reporting period from financial year to calendar year to better align with our activities and funding cycles and allow for more accurate reporting and planning. To facilitate the process and comply with ACNC requirements, CCA will report on this once off 18 month period and from January 2017 will fully adopt calendar year reporting.

This is one of many significant changes that have taken place in this reporting period. It is safe to say that CCA is undergoing a process of reinvention, with technology as its driver and an almost new Board as its leader. We are fortunate to retain the services of Dr Greg Moore and Professor Paul Pavli as well as Anita Reilly and Philip Picking and welcome James Morvell, David Reckenberg, and Alma Besserdin to the Board. Sadly, we farewelled director Ashley Rockman during the year but remain grateful for his valuable contribution. During the year, Beata Koropatwa graciously accepted the role of Chair and her leadership has already made a difference. Together we are committed to do all we can to bring positive changes to the lives of our many members and their families.

Thanks to the commitment of generous donors and dedicated volunteers and staff, CCA used digital technology to enable greater accessibility of its much loved grass roots support programs. We responded to the increasing number of requests for accessible support and information by launching iConnect, our online support platform. Reaching more than 75,000 Australians — wherever and whenever

they want — iConnect offers peer-to-peer support, live chat with IBD nurses, and useful information on managing IBD. This year, we successfully piloted the IBD forum video series on our You Tube channel, a new initiative designed to make IBD forums accessible online for people who are unable to attend them in person.

We continued to fund and lead advocacy for IBD patients with the completion of our long-awaited IBD Audit Final Report and Australian IBD Standards – part of our ongoing Quality of Care Program. In the coming 12 months, we will be surveying IBD patients to gather holistic understanding of the IBD experience and provide a body of evidence to improve the current state of IBD care in Australia.

Over this financial period, there was a drop in community fundraising and memberships, compared to last year, which contributed to the \$232, 589 deficit experienced by the organisation. We will address these issues through strategic re-investment in high yield fundraising activities and close monitoring of expenses.

We would like to take this opportunity to thank all our generous donors and corporate partners, the Board for their outstanding contribution and commitment, to our staff for their hard work and services, and of course, to the thousands of members and volunteers who provide both resources and inspiration for us to reach thousands of people living with IBD.

Looking Back at 2015/16

A NATIONALLY CONSISTENT STANDARD OF IBD CARE

IBD Audit completed | CCA IBD Audit is the first national audit of the organisation and provision of IBD care in Australia. The audit was undertaken to collect evidence on how IBD services vary across Australia and identify the reasons for this variation. It aims to inform a nationally consistent response to improve the quality of IBD care. CCA and the peak learned bodies in IBD healthcare collaborated to design a survey of hospital services and a clinical audit of patient records. 71 hospital sites participated in the audit from all States and the ACT. 1440 hospital admissions were audited.

Australian IBD Standards | CCA together with the key learned bodies in IBD healthcare in Australia and people living with IBD has developed the Australian IBD Standards: Standards of healthcare for people with inflammatory bowel disease in Australia. The standards specify nationally consistent expectations of IBD care for hospitals, healthcare professionals, IBD stakeholders and people living with IBD. Ultimately, they aim to improve the safety and quality of care for people with IBD.

Biosimilars Initiative | CCA held consultations with the Department of Health, medical professionals and patients groups to improve understanding of and confidence in biosimilar medications. The initiative aimed to increase uptake and use of

biosimilars, a highly similar version (not an exact copy) of a biologic (originator) medicine, leading to lower medicine costs and overall savings to the health care budget. With the biologic medication infliximab (Remicade®) having come off patent, a biosimilar brand (Inflectra®), is now available and has been approved and listed on the Pharmaceutical Benefits Scheme (PBS). GO-TO PLACE FOR IBD COMMENT, RESOURCES AND SUPPORT

Awareness Month 2016 | This year's awareness month focused on reaching young people through social media channels as well as reaching a broader audience through our Silver Lining Lunch in Sydney, a television commercial, which thanks to the support of WIN TV aired across regional Australia and a national building light up campaign that worked alongside our international partners to raise awareness of IBD across borders. We also launched 'How Do You View the Loo' posters and flyers that started an online conversation around different perceptions held by people on bowel disease. The campaign reached over 300,000 people online and significantly more through traditional channels of TV and print.

All new Living Well with IBD toolkit launched

| The Inside Story – A ToolKit for Living Well with IBD was updated in 2016 with the latest information regarding diet and nutrition, medications, surgery, emotional factors, children and IBD etc. This



comprehensive information kit is an extensive resource including information on over 20 different topics that can directly affect people living with Crohn's or ulcerative colitis. This 160 page information kit is the first Australian publication of its kind that includes contributions from medical experts.

The toolkit can be viewed online in the Members Only section of the CCA website. Hard copy versions are available at a cost of \$12.50 to cover postage and handling.

Information Forums

| During 2016, CCA organised Information Forums at Millwell Road



Community Centre, Canberra Hospital, Sydney

Children's Hospital Randwick and Flinders Medical Centre. The forums were attended by more than 500 people, and saw researchers and medical professionals sharing insights into a multitude of IBD-related topics including paediatrics, diet and biosimilars. Going forward in 2017, the forums will be videoed and available for online viewing on our website for

people who are unable to attend them in person.

Youth Camps | CCA held two youth camps in Redlands, Queensland and Camp Manyung, Victoria for members aged 13 to 18 years who are living with IBD. Attendees were given a platform to meet people of their own age who understand exactly what each other is going through, participate in fun activities and make lifelong friendships.

TAILORED, PERSONALISED SUPPORT ON SCALE

iConnect | CCA launched iConnect, an online platform for people seeking IBD support and a credible source of information that they can access at a time or place that is convenient for them. This online service provides a safe and confidential environment to engage in a one-on-one chat with a specialist IBD nurse or trained support crew member. iConnect also features useful resources, frequently asked questions on a range of key topics and a guideline on how to deal with a difficult situation to help anyone looking for detailed information on managing IBD.

Volunteer Program Review

| We undertook an extensive volunteer review to help us identify why people volunteer with us, what motivates them, what is important to them and how we can help them fulfil their roles. The review looked at key areas of volunteer management including recruitment, training,

leadership, reward and recognition, communication and retention.

Results from the volunteer review helped us develop right training and leadership practices to strengthen our volunteers programs.

HIGH IMPACT, GLOBALLY RELEVANT RESEARCH

Paediatric Research

Underway | Christopher Poulton, recipient of the Mandy and Edward Yencken Postgraduate Research Scholarship is studying the role of bacteria in the inflamed intestine of paediatric patients with IBD. In 2016, Chris presented preliminary research findings at School of Women's and Children's Health young investigators seminar series. This research will provide a significant advance to understanding IBD pathogenesis and should lead to improvements in IBD diagnosis and monitoring as well as potentially contributing to IBD prevention, treatment and/or cure.

COMMUNITY DEVELOPMENT

Great Wall Challenge

| Every year, many passionate CCA supporters choose to go the extra mile to raise funds. In October 2016, 20 people from the IBD community trekked the Great Wall of China to raise awareness and funds in support of CCA's support programs and research. We are grateful to all the participants and their supporters for their unrelenting effort all year long to raise an overwhelming \$100,000 in funds.

2017 New Initiatives

A NATIONALLY CONSISTENT STANDARD OF IBD CARE

Patient Experience | Following the national hospital IBD audit conducted in 2016, CCA aims to examine the experience of health care for people living with IBD and provide evidence for the improvement of quality of IBD care. As part of this initiative, CCA will survey patients with a diagnosis of Crohn's disease and ulcerative colitis or indeterminate colitis receiving outpatient public, private practice or hospital management in all States and Territories of Australia.

The findings from this survey will provide a holistic understanding of the IBD experience and help in development of appropriate tools and resources to facilitate better experiences for IBD patients, and to increase confidence in the system, compliance and health literacy, and reduce the burden of IBD.

GO-TO-PLACE FOR IBD SUPPORT

Information Hub | iConnect, CCA's online support platform, is being extended to provide a hub where content from health bloggers together with content created in-house and curated from reputable online publications are brought together to provide a comprehensive resource of the best available information on IBD and gut health.

Online Forum Series | With an aim to constantly improve what we deliver and how we deliver it, we will share videos of Information forums held in each state this year on our website. This video series will provide an opportunity to

anyone who is unable to attend the forums in person to view the forum presentations and talks online.

RESEARCH PROGRAMS

Online Research Updates

| High quality video interviews with specialists, researchers and academics will be delivered each quarter exclusively to CCA members through email and CCA's private Youtube channel. This new feature caters to the requests of members to be kept up to date with latest research news and findings in the field of IBD.

Research Grants

| CCA is committed to finding a cure for Crohn's and colitis, and will be notifying research scholars of upcoming research grants up to \$30,000 to fund

These groups provide their local communities with safe and friendly environments to meet and support other community members living with IBD, while helping to raise awareness and funds for CCA in their local communities. This year we will continue to provide training and ongoing


support to our Support Groups Facilitators, who run and organise IBD peer support groups across Australia.

CREATING AWARENESS AND EDUCATION

Awareness Month Campaign | We will run an awareness campaign throughout the month of May, which is recognised as IBD Awareness Month to coincide with World IBD Day celebrated on 19 May worldwide. This year's campaign will address the stigma associated with invisible illnesses with the 'More Than Meets the Eye' campaign. We will also 'Shine a Light on IBD' by lighting up iconic buildings and landmarks across Australia as a sign of support for those living with IBD.

El Camino Trek 2017 | This year's adventure challenge will give the IBD community an opportunity to challenge themselves physically and mentally, all while raising funds in support of the thousands of people living with Crohn's disease and colitis. From 4-13 September, the participants will get to Spain's colourful culture and cuisine on a 10-day trek along the El Camino.

At present, the quality of IBD care received is determined by a person's postcode and ease of access to gastroenterology services. Funds raised through the Crohn's & Colitis El Camino Trek will help CCA to deliver programs that ensure all Australians have access to high quality and consistent care, no matter where they live.

Our Finances

TREASURER'S REPORT

The 2016 CCA Financial Report is for an eighteen month period. Any comparison between eighteen month December 2016 and twelve month June 2015 figures need to recognise difference. All future reporting periods will be for the twelve months ended 31 December. The change was made to allow more meaningful budgeting and forecasting of results.

CCA continued investing in research, quality of care and creating an awareness across a broad audience through events and activities mentioned in the attached Annual Review.

The \$232,589 deficit has been mainly

the result of changes in the revenue streams and higher Administration expenses.

Overall revenue has risen in the eighteen month period from \$1,114,696 in 2015 to \$1,866,229 in 2016 thanks to a large increase in Sponsorship funds and a lesser increase in Government Grants. However, there was a significant decline in untied Donations (\$693,363 for eighteen months down from \$523,479) and Membership Fees (\$121,524 for eighteen months down from \$96,878) which is why CCA sought extra income assistance late 2016.

Total Expenses increased \$779,737 mainly due to increases in Administration expenses (\$624,643 up

from \$260,186) and CCA Events & other costs (\$124,754 up from \$22,786). The Administration expense increase was for mainly the IBD Quality of Care. The reduction in Awareness Program expenses (\$30,611 in 2016 and \$124,369 in 2015) was mainly due to not running the Convenience Advertising Campaign in cinemas, airports and public toilets.

The Board is carefully monitoring all operations to position CCA well into the future and is confident that with an increase in Donations to previous levels and expenses under control, CCA will continue to perform well in the next financial year.
